UTAH GOOD SAM STATE COMMITTEE MEETING

Sept. 9, 2017

Delta, Utah

Al called the meeting or order at 11:00 and roll call was made. All chapters were represented with the exception of: Color Country Ramblers, No. Utah Golden Spikers, Tooele Travelers and

Weber Waffies.

Nominations for State Treasurer are needed within 30 days. An email will be sent to Chapter Presidents to get their input. Jerry Griffin suggested giving the Treasurer a small stipend for the position since it is a very time consuming job. Susen Zobel stated that all Good Sam positions involve time and effort and no one gets paid. It was decided to keep all positions on a strictly

volunteer basis.

Harold reported on the Nomination Committee criteria. A copy is attached to this document.

Amounts for donations cannot be determined until a Treasurer's report can be obtained.

Donations for 2015 consisted of:

Dogs for the Deaf - \$500 Wounded Warriors - \$500 The Christmas Box - \$500 PJ's for Forgotten Children - \$500

Motion: Rulon Gamon - Appropriate a specific amount to donate to an organization that supports Good Sams.

After much discussion the motion was withdrawn.

Other suggestions for donations were:

- * Donate something tangible (such as a piece of equipment) instead of money. It was discussed and seemed to be something we might be able to pursue.
- * Could we build donations into the registration fee? We need to appropriate our donations on monies brought in over and above expenses not as a separate fee.

Harold explained how the system has worked in the past. Donations are made after all Rally & Tag expenses have been paid. Then the amount determined available for donations is divided among those charities that are chosen by the State Committee.

stated.

A copy of the 2018 Rally/Tag chapter assignments was handed out. This list will stand as is for now. Changes may have to be made closer to the Rally. Every chapter will have the opportunity to fulfill the assignments. A Chapter Advisor/Liaison list, as well as a copy of the assignment description was also handed out (a copy of each is attached. Presidents were encouraged to read the descriptions so there would be no question as to exactly what their responsibilities entail. Copies of the handout were emailed to the Presidents of the Chapters not in attendance.

Marty Zobel volunteered to take the assignment for Bocce Ball.

It was asked if the People Mover could be reinstated. We don't know if we could get the truck donated again and it's not feasible to use a private vehicle for this purpose. It may be possible to get a golf cart for use on a "taxi" basis. Those wishing the use would have to request to be transported at a specific time. It was also brought up that chapter members with available vehicles could be helpful in making sure those that needed rides to events could be provided.

Motion: Rulon Gamon - Not to reinstate the use of the People Mover for 2018.

Seconded: Gerry Sealy

Vote was a tie. Director Al Andrew cast the tie breaker. The People Mover will not be

reinstated in 2018.

Motion carried

The question was asked about what to do with the People Mover. Paul stated that a new cover is needed. Al said he has a brand new motor home cover that he is certain will fit and offered it to the Club for the People Mover. For now, we will continue to store it in its present location.

Rulon suggested we have an aluminum tab collection contest between the chapters. After discussion, it was decided to just have everyone bring their tabs to the Rally, see how many can be accumulated and donate them as one big donation.

Susen queried the members about how the current distribution of the Salty Sam is working for them. Most agreed that is was effective and an efficient way to get the news letter out to our members, so it will continue as it is. For those members that don't have access to computers, chapter Presidents or their representative should make sure everyone gets a copy. Bob also reminded everyone that the Salty Sam is on our webpage and can be accessed at any time.

The Presidents list information needs to be updated. If you are a new president please let Arlene know.

Phil Wheeler made the suggestion that we change the way we handle arrival times for the Rally. Using the 2017 arrival list, rotate the arrival times each year. This way it will allow every chapter to have a preferred arrival time. The exceptions to this would be: The Greeters, Decorations and Chapter of the Year which will arrive a day earlier. Upon their arrival, the Presidents will have the opportunity to choose where they want to be parked. No prior arrangements will be allowed.
