February 6, 2021

Harold greeted everyone and thanked them for attending our meeting.

The pledge was led by Dale Wallace.

Reverence was offered by Bob Anderson.

Roll call was conducted by Arlene Hales. Those chapters represented were: Happy Hobos,

Lee Gillman went through the Financial Report for 2019 and 2020. Since there was no action on the report for 2020 there was no discussion.

Motion passed

Lee stated that an audit needed to be performed. This has to be done by Chapter Presidents and the Treasurer and he asked for volunteers. Gerry Seele and Dale Wallace volunteered to be on the committee.

Harold reminded us that the State Committee is required to attend four meetings annually. They are the Spring meeting (April 17, 2021, Aspen Grove); State Rally, Fall Tag, and Winter meeting Dec. 4, the place TBD.

Harold started out with a discussion on the future of the Salty Sam. The consensus was: There will be no official publishing of the Salty Sam. Marcus has committed to do something to keep our current members and to entice new ones to join us. There has not been much progress in this area and the jury is still out as to whether anything will come out of this project.

Harold noted that it is no longer required that new members have a Good Sam national membership number as we do not need to send chapter membership to the national office anymore. But we should encourage chapter members to join the Good Sam.. Chapter and State dues will still be required as in the past.

Bob explained the web security system. There is no longer any personal contact info listed.

Harold and Rosie expressed their appreciation to everyone on the State Staff and the Committee. Harold presented Bob & Cathi and Paul & Arlene with an outdoor mat. And all of last years Chapter Presidents and state staff were given a door mat and tablecloth. We will miss all the stories about Harold's brothers.
