Roll Call and update of Chapter Rosters: Gerry Seele. Presidents were asked to fill out a Chapter Officer form.

**MINUTES**: Read by Gerry Seele of Sept 18,2021 State Committee Meeting at Delta.

**MOTION**: John Sandberg of Over the Hill Sams made a motion to accept the minutes as read.

**SECONDED**: Gary Houston of Utah Deer Sams seconded the motion to approve the minutes - Motion passed

**TREASURERS REPORT**: Lee Gillman, State Treasurer- The Fall Tag receipts were \$5,996.26 and we had expenses of \$5,127.44

**MOTION**: Mike Johnson of Happy Hobos made a motion to accept the report as read

**SECONDED**: Gary Houston of Utah Deer Sams seconded the motion to approve the treasurers report. - Motion passed

Gwen Shoemaker was introduced as the new Treasurer, Replacing Lee Gillman. She was sworn in and will be taking office January 1, 2022.

The State Staff was recognized for their work at the Fall Tag. Special thanks was given to John Saxey for his work on the Model T Blastoff and his work on the State Staff. Scott and SharLee Spencer of Squaw Peak Sams were welcomed as new State Staff members replacing John.

**STATE COMPS**: Harold Jacklin led a discussion on operational procedures for the Utah State Director, recognizing the additional work and the added out of pocket expenses required to accomplish the duties of the State Director.

Fall Tag and Rally: We will rename the "Merchandise Booth" to The "Good Sam Country Store". Pat Smith will be getting merchandise from several retailers at a **good** discount, and will sell them at that price. But so that we can earn a little money for charity, suggested that we add a dollar to the cost of each item.
