MINUTES: The minutes of the State Committee Meeting held on September 25, 2025 in Delta Utah were read.

MOTION: John VanDorn of the Rocky Mountain Campers made a motion to approve the minutes as read.

MOTION: Karen Paxman of the Utah Sun Chasers seconded the motion. The motion passed.

John Saxey presented Gwen Shoemaker's name for our vote as the State Treasurer.
